



HOST FAMILY AGREEMENT ADDENDUM

This is an addendum to the existing host family agreement between MLI Homestay

Terms:

Host Family – is you the family hosting the international student

Visitors – is a CISS or MLI international student

MLI Homestay – is the company providing the homestay services for international visitors

The following clauses have been added, changed, or amended, please initial below to confirm that you have read these changes, and by initialing them you are agreeing to the terms below.

As an MLI Homestay Host Family I/we agree to the following regulations:

- 1) _____ e. there will be no possession or use of cannabis in the home by any family member or guests visiting the home

- 2) I/We understand that if our family structure or composition changes we will notify MLI Homestay immediately. Examples of family structure / composition changes are: hosting another international student, within the MLI Homestay guidelines, having a son or daughter return home to live with the family, having a relative come to live with the family, having a family friend move in with the family. MLI Homestay is required to notify the agent, school or natural parents of any changes to family structure or composition.

Hosting Minors

- 3) I/we understand that minors (Visitors under 18 years of age) must not be left home without supervision for extended periods and forbidden to leave them unaccompanied overnight. In the event that I/we must be away due to an unforeseen circumstance and cannot provide accommodation, I/we will contact MLI Homestay to provide details for a responsible adult who will stay in the home with the student or suggest accommodation with a relative or friend that is able to take on the homestay responsibilities for the period we will not be available. In the case that we have no alternate arrangements available we will contact MLI Homestay for assistance with alternate arrangements.
- 4) I/we understand that there will be no serving or sharing of alcohol or drugs or cannabis to minors in the home.

Legal Obligations

- 5) I/We will ensure that Visitor(s) abide by the federal and provincial laws of Canada. Visitors must only use drugs prescribed by a medical practitioner. The use or possession of any type of illegal drugs, or the abuse of prescription or non-prescription medications is an illegal activity in Canada. The consumption or possession of alcoholic beverages, cannabis and the purchase of cigarettes and tobacco products is illegal for persons under the age of 19 (18 in some provinces). Purchasing alcohol, cannabis or tobacco products on a minor's behalf is illegal.
- 6) **Automobiles / Motorcycles:** Visitors must not be permitted to drive the family vehicle or borrow any type of motorized vehicle from the family. Minors are not allowed to ride in a car with a driver who is under 25 years of age. Visitors are not permitted to ride on motorcycles or be driven to and from any programme on a motorcycle.

I/We acknowledge that I have read, understood and agree to all the above amended and conditions of the Host Family Agreement. This Host Family Agreement must be signed by all adults over 18 years of age in the home, and it replaces and supersedes any pervious MLI Homestay agreement.
